1. You must be a resident of Jefferson County
2. You must be 14 yrs old and not over 17yrs old by July 10, 2011
3. You must written consent from a parent or guardian.
4. You cannot be a former Jefferson County Fair Junior Queen.
5. There will be a First Place Winner who will serve as the Jefferson County Fair Junior Queen for one year from the date of this contest. A first and second runner up will Also be selected. You must be available to attend fair related events.
6. All contestants will be competing in three categories: poise and personal appearance, Talent presentation, and question response.
7. You must furnish all of your own music. The fair will provide a sound system. A CD/Tape Player will be available. No "burned" CD's will be accepted for use In this competition.
8. Your talent should be no longer than 5 minutes.
9. You must follow the "DRESS CODE" set forth by the Jefferson County Fair Authority
10. Each contestant should have a GREAT time.

The Pageant will be held on Sunday, July 17, 2011 at the Jefferson County Fairgrounds at 2:30 p.m. All contestants must be present by 1:30 p.m

DRESS CODE and CODE OF CONDUCT

The following DRESS CODE and CODE OF CONDUCT applies to those individuals that are representing Jefferson County Fair as Queen, 1<sup>st</sup> and 2<sup>nd</sup> Runner-up, and the Junior Queen, 1<sup>st</sup> and 2<sup>nd</sup> Runner-up.

Clothing with inappropriate slogans or illustrations, vulgarities, or derogatory comments will not be permitted. You are not to wear clothing that serves as an advertisement for drugs, alcohol, tobacco, or whose messages represent a double meaning.

Halters, tube tops, net shirts, tank tops, bare midriffs, or off the shoulder tops are not permitted. Sleeveless tops are permitted as long as they do not have spaghetti straps or reveal any undergarments. Modesty must be maintained.

No oversized clothing will be permitted. All jeans and pants must be properly fitting and intact. Low rise pants or jeans that compromise modesty must not be worn.

If shorts are worn they cannot be tight-fitting or short shorts. The rule to follow is when standing with your arms at your sides, the shorts must be finger tip length. This also applies to skirts and dresses.

For your safety no flip flops will be permitted. Your duties require you to enter the barns, show arena, and travel up and down the grandstand.
